#### **Non-endowed Gifts**

• 48% of foundations assessed fees on non-endowed gifts in FY21. Most common fee was 5% charged by 55% of foundations assessing the fee. The minimum fee was 3%, maximum fee was 6.5%.

#### **Endowed Gifts**

34% of foundations assessed fees on endowed gifts in FY21. Most common fee
was 5% charged by 45% of foundations assessing the fee. The minimum fee was
1.25%, maximum fee was 6.5%.
