

CASE Europe Awards 2020 – FAQs and Eligibility criteria

How much does a nomination cost?

The fee for each nomination is £40/50 EUR.

Can I nominate more than one colleague for an award?

Yes, you can nominate as many colleagues as you wish for each award, in separate nominations. All awards, except for the Volunteer of the Year Award, recognise one individual. It is possible to nominate an individual volunteer or a team of volunteers for the Volunteer of the Year Award.

Can I nominate myself for an award?

You can nominate yourself for the Schools Engagement Award or Volunteer of the Year Award. Nominations for all other awards must be made by a colleague or line-manager.

When is the deadline for nominations?

The deadline for nominations is 17 June 2020.

Distinguished Service Award	The CASE Europe Distinguished Service Award celebrates the work of individuals whose professional accomplishments have made a significant and lasting impact and whose life and character have earned the respect and admiration of their peers, inside and outside their own institution.	<p>This award recognises the following contributions from an individual:</p> <ul style="list-style-type: none"> • Leadership in their profession • Demonstration of best practice within their profession • Contribution to their profession • Innovation • Service to the CASE Europe community

<p>Ian More Award</p>	<p>The CASE Europe Ian More Award recognises outstanding achievements of an emerging development professional.</p>	<ul style="list-style-type: none"> • The nomination must demonstrate measurable evidence of excellence, innovation, impact and integrity in fundraising from the nominee • The nomination must also show the nominee's commitment to the profession through the sharing of best practice, volunteering and/or speaking in a professional capacity • The nomination must detail the nominee's career achievements but also show a track record of consistent and credible performance • Nominations must be submitted by the nominees' line manager or a senior member of staff in the nominee's institution.
<p>Volunteer of the Year Award</p>	<p>The CASE Europe Volunteer of the Year Award recognises the outstanding achievements of a volunteer, or team of volunteers, who have enhanced and sustained an institution's advancement performance.</p> <p>You can nominate yourself or your team for this award.</p>	<ul style="list-style-type: none"> • The nomination must demonstrate measurable evidence of the nominee enhancing the institution's advancement performance • Nominations must demonstrate the nominee's commitment to their profession and the institution they support • Nominations must be endorsed by a senior advancement professional (e.g. director of development or the head of the relevant CASE member institution/organisation)
<p>Leadership Award</p>	<p>The CASE Europe Leadership Award recognises heads, presidents, vice-chancellors, chancellors, principals, rectors/rectrices and other organisational leaders for their outstanding efforts in promoting and supporting education.</p>	<p>Nominees for this award must demonstrate the ability to:</p> <ul style="list-style-type: none"> • Actively support advancement • Create a vision and inspire others • Establish a positive image for their institution while leading it to higher levels of success • Increase their institution's stature in the community • Encourage innovation and risk-taking among employees

<p>Schools Engagement Award</p>	<p>The CASE Europe Schools Engagement Award recognises innovative programmes of external engagement and enhancement of relationships between a school and its community.</p> <p>You may nominate yourself for this award.</p>	<ul style="list-style-type: none"> • The nomination should demonstrate the nominee's leadership in the pursuit of a school's/college's mission through engagement with stakeholders • The nomination must include measurable evidence of excellence, innovation and impact • The nomination must demonstrate the particular achievements of the nominee and show a track record of consistent and credible performance
<p>Martin Bojam Emerging Marketing and Communications Professional Award</p>	<p>The CASE Europe Martin Bojam Emerging Marketing and Communications Professional Award recognises outstanding achievements of an emerging Marketing and Communications professional.</p> <p>This award was named after popular CASE volunteer Martin Bojam, who passed away in 2019. Known for his warmth, good humour, and commitment to CASE's vision of advancing education to transform lives and society, Martin Bojam was a mentor and friend to many in the CASE community. Donate to the Martin Bojam fund here.</p>	<ul style="list-style-type: none"> • Applications must be submitted by the nominees' line manager, and endorsed by someone from the senior management team. • Nominees must demonstrate measurable evidence of excellence, innovation, impact and effectiveness in alumni & external relations. For example, increased alumni or external engagement, impact on the wider university aims e.g student employability/recruitment, relationship management. • They must also show a commitment to the profession through sharing good practice and engaging with peers, as well as seeking volunteer opportunities in the profession such as speaking at conferences and seminars. • They must demonstrate particular achievements in their career, but also show a track record of consistent and credible performance.

<p>Emerging Alumni & Supporter Relations Award</p>	<p>The CASE Europe Emerging Alumni & Supporter Relations Award recognises outstanding achievements of an emerging Alumni & Supporter Relations professional.</p>	<ul style="list-style-type: none">• Nomination must come from the nominee's line manager.• Nominations must be endorsed by a member of the institution's/organisation's senior management team.• Nominations must demonstrate measurable evidence of the nominee's excellence, innovation, impact and integrity in their professional work.• Nominations must demonstrate a nominee's commitment to the profession through the sharing of best practice, engaging with peers, volunteering and/or speaking in a professional capacity.• Nominations must demonstrate the nominee's particular achievements in their career, but also show a track record of consistent and credible performance.
