How to Use this Guide

This guide helps readers learn what data are collected on the CASE Insights on Voluntary Support of Education (VSE) survey and find the data variables in the [CASE Insights data portal](#) (formerly AMAtlas Data Miner) to use in benchmarking reports.

- Learn about the core data report for the VSE survey, higher education, which was created by the CASE Insights staff and is available to all data portal users on its home page.
- The questions from all versions of the VSE survey are displayed in grids in this document.
- Each data collection field has a code.
- Following each question grid is a list of the data field codes mapped to their corresponding variable family (grouping of related variables) and variable name in the data portal.

Survey Versions

There are three versions of the VSE survey: the full, the partial, and the minimal.

- Sections 1, 2, 2b, 4a, and 4b are the same on all versions of the survey. Only section 3 varies between survey versions.
- All questions in section 2, section 3 (minimal version) or section 3a, 3b, and 3c (full/partial version), and 4a are required for all participants.
- All questions in sections 1, 2b, and 4b are optional on all versions of the survey.

Survey Reporting Standards

Beginning in 2022, the VSE survey aligns with the [CASE Global Reporting Standards](#). The full standards document can be purchased in print or digital format.

A shorter guidance document to assist survey participants is available on the [VSE survey help page](#), but it is highly recommended that participants obtain a copy of the full reporting standards.

The survey help page also includes a document covering the changes to the survey beginning in 2022 as well as other support materials.

Core Data Report: VSE Survey Higher Education (2022+)

About the Core Data Report

The core data report includes more than 25 columns of required data from the VSE survey. It can be found on the data portal home page in the Recommended Reports section.

The 2022+ core data report contains variables from the latest version of the survey, which aligns with the CASE Global Reporting Standards. For pre-2022 survey years, use the earlier version of the report titled “Core Data, Higher Education VSE Survey (2004-2021),” which can be found in the data portal by selecting Reports > Saved Reports from the main menu and searching for the report title.

How to Use the Core Data Report

- On the data portal home page under Recommended Reports, click the open folder icon to the right of the report name to open it.
- Click the Copy button to copy the report, so you can customize it.
- Click the Edit Inputs button to make changes to the report parameters. Most users will want to remove the default comparison group used in the report and add the comparison group or institutions they would like to use.
- After making your inputs edits, click the Run Report button to refresh it with your selections.
- You can then save your report and download it as a CSV file.
